If the Monitoring Officer agrees that your interest(s) constitutes a sensitive interest for the purposes of section 32 of the Localism Act 2011, the information will be recorded but the copy of the register made available for public inspection will specify that an interest has been disclosed but is withheld under Section 32 of the Localism Act and with the agreement of the Monitoring Officer.

2. Sponsorship

Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by M in carrying out duties as a member, or towards the election expenses of M. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
